Council directed staff to modify the report for clarity. Council identified that there needs to be clarification and review of the current agreement with the Southwest New Brunswick Service Commission regarding development officers and representation on land use planning.

NEW BUSINESS

Quoddy Shores Homeowners Association Request

A request was presented to Council from the Quoddy Shores Homeowners Association asking for snow plowing services and roadside garbage collection in the Quoddy Shores Subdivision. This area is a private subdivision regulated by a development agreement from 2011.

CAO Spear noted to Council that it is staff's belief to not do work on private roadways with Town staff and equipment. The development agreement signed outlined responsibilities of maintenance, snow clearing, and garbage removal. The private road and subdivision are provided limited services under the agreement. Staff asked for direction from Council on how to proceed.

Council discussed the possibility of accepting the road if it meets municipal standards and it were to become a public road versus a private road. Private entry would be eliminated in this area if it became a public road. In 2018, Council approved the installation of a garbage bin at the end of Quoddy Shore Drive for garbage collection. Staff noted that a review of the road with Public Works and the Municipal Engineer would need to occur to determine the current road level and needs to make it a municipal road. Council noted that they do not want to set precedence on Town equipment and staff work on private roads. Council directed staff to discuss Council's concerns with the Quoddy Shores representative and what direction they want to go. A report will come forward in December 2020.

Use of Meeting Rooms at W.C. O'Neill Arena Complex

CAO Spear noted that the Town is receiving more requests from non-profit organizations regarding use of the W.C. O'Neill Arena Complex meeting space. Due to limitations of many groups for space and COVID-19, the Arena provides a large venue with social distancing space for meetings. Staff asked for direction on bookings and rental rates.

Council directed staff that it is at the discretion of the CAO for bookings and rental rates. Council had no concerns on staff direction and ask.

Fence Request from 33 Water Street Sheila Washburn

CAO Spear noted that 33 Water Street has requested to install a new deer fence to protect their gardens and yard. They have requested a 6-foot fence in the front yard of their property. Under the current Zoning By-Law fence in the front yard can only be 3-foot height. The deer fencing issue needs to be addressed in the Zoning By-Law, but Council should review the request.

Council discussed the need to address the deer fencing issue and that this would be brought forward at the next Zoning By-Law workshop in November. Council acknowledged the request from 33 Water Street and that the property needs to be protected as the gardens have been a staple in the community for decades. Council noted that a consistent town wide approach needs to be taken with deer fencing. Council directed staff to bring the deer fence discussion forward to the next Zoning By-Law meeting before providing 33 Water Street with an answer on the installation of new fencing.

New Brunswick Community College Request for Snow Clearing and the Noise By-Law

Clerk Nopper noted that the Town received a request on behalf of the New Brunswick Community College asking for an exemption to the Noise By-Law to start snow clearing at 5:00 a.m. Staff noted that under By-Law 06-04 Concerning Regulating Noise in the Town of Saint Andrews that currently noise cannot occur until 7:00 a.m. NBCC needs to start at 5:00 a.m. to clear the lot and area of snow by 6:30 a.m. for the safety of the students and staff, and instructors. Council would need to provide an exemption to NBCC for the snow clearing request. Staff recommended that Council may want to revisit the By-Law in the future to address noise for snow clearing for the entire community.

Council concurred with staff's assessment and directed a motion be brought to the November 2, 2020 meeting to provide exemption to NBCC under By-Law 06-04 to allow for earlier start time for snow clearing.

Councillor Groulx – Asked that Council make the Active Transportation Plan a priority moving forward based on the upcoming grant funding for trail development. The request was to start discussions in November and December.

Mayor Naish – Supported the priority of the Active Transportation Plan and the trail plan for the grant funding opportunity. Additionally, we should be matching up with the recent construction projects by the Department of Transportation and Infrastructure on the work on Highway 127 to be ready for the Coastal Link Trail.

Councillor Groul - Asked staff when Council will be given a tour of the Wellness Centre.

CAO Spear – Staff are hoping to provide a tour to Council in November. The floors are being installed and once the major work has been completed, a tour will be provided. We anticipate a December opening and tour for the general public.

CAO Spear – With the 2021 Budget almost completed, does Council have any issue with a motion being brought forward at the Regular Council Meeting in November to pass the Budget?

Council – Consensus was given to bring forward the motion for the 2021 Budget at the next Regular Council Meeting in November.
