### E. INTRODUCTION, CONSIDERATION AND PASSING OF BY-LAWS AND MOTIONS

## 1. Council Resolution on Terms and Conditions for Rezoning 108 Sophia Street, PED210404

Council had a discussion on the proposed rezoning of 108 Sophia Street. Several amendments were proposed to the Council Resolution for 108 Sophia Street including the refund of the rezoning application fee, the addition of fencing to the property, and that the property can revert to service residential if no longer a vet clinic. Council debated these amendments with a focus on the fencing amendment. Dr. Matheson was contacted by the CAO to discuss the amendments presented. Council came to a consensus, on the feedback from Dr. Matheson, to move forward with the fencing amendment. Council was noted that the refunding would need to be a separate motion from this decision process. Staff was directed to bring a motion forward for the Regular Council Meeting on May 3<sup>rd</sup>.

That Council makes the following amended resolution with terms and conditions for the rezoning of 108 Sophia Street for Dr. Tami Matheson and Dr. Krista McAllister:

- 1. All kennels must be in the main building.
- 2. Any future use must be similar to or compatible with a veterinary clinic and the surrounding residential neighbourhood in the opinion of Council.
- 3. The appearance of the upper windows and gables must be maintained. If repair of an existing window or gable element is not possible, the replacement must be of the same building materials (or adequate facsimile), size, and style of the element being replaced.
- 4. Vinyl siding must not be used in any repair or restoration. If restoration of the current siding is not possible, materials that mimic the current siding such as engineered wood, concrete fibreboard, or equivalent must be used.
- 5. That a six-foot-high wooden fence be built to the satisfaction of the Chief Administrative Officer be constructed between the veterinary clinic and adjacent neighbours on both sides of the clinic along Montague Street and Sophia Street.
