Councillor Groulx - I think that this request to refund the application fee may raise a larger question. Should we be charging a \$1,000 fee for rezoning? I think this is a steep fee and next Council should look at this.

Councillor Harrison - With this one, we turned this away at the beginning without using staff time. I back this one.

CAO Spear - As Councillor Harrison pointed out, the plan was rejected, but the fee is there to help discourage rezoning's. If people want to go through the process, then they have to pay a high fee to make it worth everyone's effort. We can relook at the fee but we feel this fee is standard.

Planner Gopen - The price varies between municipalities but \$1,000 is standard. In other communities like Dieppe it can range over \$1,500 - \$3,000. We are discussing some new fees to lower and will present to Council. The rezoning fee is standard and makes people hard consider rezoning.
