1. Saint Andrews Outdoor Recreation and Trails Inc. Request for Funding Trail Maintenance, RCS210806

CAO Spear reported that SORTI has provided a request for funding of up to \$5,000.00 to help with the maintenance of trails. Typically, this is a budgetary item and the request is coming late for 2021. This brings up a larger conversation on trails and agreements for the maintenance. Town Council should discuss the trail crossings onto private properties and the need for formal agreements. Staff has identified areas to which funding can be found based on surpluses or use of Assistance Grants. Staff also noted that \$65,000.00 was spent on the repairs to the trail at Katy's Cove due to storm damage.

Council Heenan motioned, and Councillor Hirtle seconded for a formal motion be brought forward in the amount of \$5,000.00 for debate.

2. Trail Development Projects and Public Consultation Discussion - RCS210807

CAO Spear - Key issues, indigenous consultation is completed but on hold. We had discussed doing Cemetery Road and Katy's Cove, timing with weather may get delayed. We are going to have to do public consultation for the rest of the project. SORTI has recommendations on how they would like to design it. We will include their recommendations and will be brought forward to this Council. Traffic patterns could change depending on decisions so public consultation is needed.

Council discussed the need to have a greater conversation with SORTI to understand their asks and wants from the trail network. Council will also review the Transportation Master Plan and get information on the Coastal Link Trail. Council will have to have a working session to understand and develop the priorities of the trail before going to public consultation. Council requested a Special Meeting of Council with a presentation from SORTI and further discussion on the next steps to the trail process.

6. Planning & Economic Development - Councillor Heenan

1. By-Law 21-04, A By-Law Respecting Encroachment Upon Public Streets in the Town of Saint Andrews First Reading, PED210805

Staff noted that the Encroachment By-Law 21-04 has been developed to have a review process for the use of public rights-of-way and encroachment onto public spaces. This By-Law includes signage, extended sidewalk uses, construction uses, and placements of structures on public spaces. Currently, encroachment requests come to Council for discussion and decision. By-Law 21-04 would give the authority, under Council, for staff to approve encroachment requests on public spaces. Staff also brought up this By-Law for the protection of the taxpayers for insurance purposes.

Council discussed sandwich board signs, the permitting process, and their use for businesses. Council had concerns regarding the additional permitting process and cost for sandwich board signs that are used by businesses. Council felt that adding an additional cost and application process is onerous and needs to be reviewed. The direction was provided to staff to review the sandwich board sign

process and simplify it under the draft Encroachment By-Law 21-04. Staff will provide a report for the Regular Council Meeting outlining recommended simplification to the process. Council also directed staff to include a Public Hearing of Objections motion to the Regular Council Meeting.
