- I. INTRODUCTION, CONSIDERATION AND PASSING OF BY-LAWS AND MOTIONS

    - 1. By-Law No. 22 07, A By-Law Relating to the Town of Saint Andrews Council Remuneration, FA221115

CAO Spear provided a presentation on the proposed Council Remuneration. The presentation highlighted the importance of adequate compensation for Council Members to help attract quality candidates, to compensate for hours of work, and high-stress situations, and to be more inclusive. Remuneration is being discussed now as the Province of New Brunswick is implementing new Council remunerations across the province for all municipalities that are going to full general elections. A comparison of the new rates for St. Stephen, Eastern Charlotte, Fundy St. Martin, Shippagan, and Shediac was used as a comparison. Those communities, six in the province, will be going to bi-elections, and the decision is left to those Councils on remuneration. The proposed remuneration was calculated based on a scoring matrix composed of population size, services provided, number of institutions, infrastructure, and government services, average tax base per resident, and size of the territory. This matrix was developed by the Association of Francophone Municipalities of New Brunswick and has been implemented by other municipalities. Recommended remunerations include for Mayor \$34,400 - \$42,650, Deputy Mayor \$14,7892 -\$20,472, and Councillors \$13,072 - \$18,339. The remuneration would put the Council in line at the lower end of the remuneration spectrum in comparison to other similar municipalities.

Council thanked the staff for the thorough analysis of the proposed funding. Mayor Henderson reiterated that the province had a chance to implement the new remuneration by their decision but left it to Council. Council discussed the remuneration option noting that they would like to start on the lower end of the scale for remunerations. It was noted that to continue drawing potential candidates, to support the hours worked, and to deal with the stresses of the position, it is reasonable to increase the Council's remuneration. Council noted that there would be a Public Hearing of Objections on the proposed remuneration on Monday, December 12, 2022.

#### J. NEW BUSINESS

# 1. Request for Extension of Champlain Avenue Housing Request for Proposal Submission Date

CAO Spear noted that the Town has received a request to extend the Champlain Avenue Housing Request for Proposal from the December 5th, 2022, date to delay to early February 2022. We have six or seven groups that have taken a copy of the RFP. The concern is if we extend the deadline to February, it will take staff time to review the scoring and bring it back to Council. From there it may take the rest of the year to come to an agreement and work may not commence until 2024. Clerk Nopper noted that the RFP has been released for 60 days. Council discussed the option of an extension of the deadline but noted that this is a competition and workforce development, and how it is fair to extend it. It would not be fair to the proponents working on it. Council also reiterated that they do not have to approve any of the RFPs. Council had a consensus to leave the date of December 5th, 2022, as the closing date.

# 2. Meeting Schedule for January 2023 for Council

CAO Spear noted that staff will not be back in the office until January 3rd, 2023, which would give limited time for the development of an Agenda Package for January 9th. It is recommended that Council have a workshop session with the new Councillors on the Registers and that the first Regular Council Meeting should take place on January 16th, 2023. Clerk Nopper noted that the swearing-in ceremony for new Councillors would need to take place between December 8th, 2022, and December 23rd, 2022. Council had a consensus on the dates for the January 2023 meetings and for staff to arrange the swearing-in ceremony in December and to try to align with the December 12th Public Hearing of Objections. Staff will bring forward an official motion of Council at the December 5th, 2022, meeting.
