E. PRESENTATIONS

1. Alexandra Woodworth, Presentation from New Brunswick Power on the Development of Small Modular Reactors at Point Lepreau

Ms. Heather McKnight, presented on behalf of New Brunswick Power regarding an update on the Advanced Small Modular Reactor Development. Ms. Knight highlighted the need for energy change drivers with climate change, energy security, costs, economic benefits, and innovation mindsets. Noted that New Brunswick Power is looking at all alternative energy sources to provide power to New Brunswick and for selling purposes. Looking at a phase-out of fossil fuels and looking towards hydro generation, nuclear, biomass, wind, solar, and imports. New Brunswick is at the forefront of the development of advanced reactor technologies at Point Lepreau between now and the mid-2030s. Ms. Knight discussed the ARC-100 Sodium Cooled Fast Reactors in development and the current activities taking place and the goal of sustainability. Ms. Knight noted another reactor in development called the Moltex Energy SSR-W Salt Fast Reactor. This is another style of reactor in development and is projected to be in place by the late 2030s. It was noted that many business

sectors for supply chain management are looking at these energy types including manufacturing and assembly, engineering and technology support, materials, labour, planning and management, quality assurance, environmental and safety, transportation, and ongoing technical and fleet supports.

Council thanked Ms. Knight for her presentation and descriptions of the ARC-100 and Moltex Reactors. It was noted that these reactors can reuse the fuels being used at multiple nuclear facilities in Canada. Council asked what would be done with the spent fuel after being in the new reactors. Ms. Knight noted they are working on long-term storage for these fuels, including those used in the current reactors. This is a cross-Canada process but the storage units would need to be resized and shaped. Different material considerations for long-term canisters to prevent leakage. Finland was brought forward as an example of working on long-term nuclear waste disposal. Ms. Knight stated that four ARC Reactors and one Moltex Reactor are looking to be built on the Point Lepreau site. There is a lot of opportunity to build in these areas. Council noted energy requirements are going up and what programs and uptake have been provided to drive energy usage down. Mr. Bob Scott from New Brunswick Power, noted they have had great success with the heat pump programs and are working on alternative measures, noting the Shediac solar field recently installed.
