### E. PRESENTATIONS

1. Franklin Cardy, Charlotte County Archives Presentation on Staffing Request through Community Grant Application

Mr. Franklin Cardy provided a presentation video to Council regarding the processes and business of the Charlotte County Archives. The video highlighted functions of the Archives, fundraising and donation processes, tourism numbers, facility tours, and the need for funding to help support the tours for the 2023 season.

Council thanked Mr. Cardy for the informative video. Council asked as this is a Charlotte County Archives if other Municipalities provide support for their initiatives. Mr. Cardy acknowledged that they are working on sourcing funds from other Municipalities but currently are not receiving funds. Council asked why the Archives is looking for three students for summer tours. Mr. Cardy noted that three students allow them to provide tours 7 days a week.

COVID was a factor in their reduced capacity over the last several years. Council asked if donations they receive from the tours help to offset costs. Mr. Cardy noted that tours do bring in extra revenue through donations but usually cannot cover the total cost of the student staff. Council noted that they do have limited funds under the Community Assistance Grants but would discuss the request at the next Regular Council Meeting.

# 2. Sunbury Shores Presentation on Capital Project Expansion Community Assistance Grant

Mr. Gerald McEachern provided Council with a presentation on the proposed upgrades to the Sunbury Shores community art class space. The goal of the project is to create more space for storage, and usable training space, expansion of washrooms and shower stations, and enhance instructor space. Council was provided with an overlay concept of the changes to the community room space. It was also brought forward that the Town is one of nine communities with a provincially recognized cultural and arts space. It was also stated that other communities, Bouctouche, Florenceville, and Sussex are provided funding or supported through building use and upkeep by their municipalities. The Town of Saint Andrews may want to consider this option in the future.

Council thanked Mr. McEachern for his presentation on the upgrading of the community rooms at Sunbury Shores. Council asked what other communities provide to their art centres. Mr. McEachern did not have the figures on hand. Staff noted that information would be brought forward to the next meeting regarding the communities that provide funding to their art centres. Council noted that the request for funds was high and limited funds in the Community Assistant Grants. Council would discuss the request for funds at the next Regular Council Meeting.

# 3. Town of Saint Andrews and Explore St. Andrews Presentation on Tourism Accommodation Levy 2023 Budget

Clerk Nopper provided an overview of how funds have been collected and distributed for the Tourism Accommodation Levy. From the Town portion, in 2021, the Town provided funds to ExploreStAndrews to help kickstart their process. The funds collected from the 2021 and 2022 seasons were held until projects were deemed tourism infrastructure. In 2023 the Town is looking to spend funds on new tourism signs and a new washroom to be built at Indian Point Park.

Mrs. Christy Kennedy, Chair of ExploreStAndrews provided a presentation to Council on the ongoing processes of the Board, marketing and promotion initiatives, community grants given, and to hire of a staff member to help with the implementation of the marketing and promotion initiatives. Mrs. Kennedy provided Council with a budget breakdown for the 2023 season.

Council thanked Mrs. Kennedy for her presentation and noted that this was the most thorough budget that has been presented to date from ExploreStAndrews. It was noted that the Town is currently reviewing and moving the new version of the Tourism Accommodation Levy through the By-Law process, which would include the Wards of Bayside and Chamcook. Council would review the budget presented and look to approve at the next Regular Council Meeting.

CAO Spear updated Council on the current processes for accepting complaints and the review mechanisms associated. It was noted that the Town was working to identify which Provincial agencies were handling issues in the Wards of Bayside and Chamcook. Discussions were had with the previous LSD Representatives and how they handled issues in the former LSDs. Staff are compiling an educational list of information for the public but recommended that the public contact the Town and have their complaints addressed by staff. It was noted that the changes brought forward with the Local Governance Reform have left some processes unattended and need to be addressed.

Council thanked staff for the update on the complaint processes and continued directing the public to Town Hall. It was asked if staff can create a mailout and educational information to be put on the website with the appropriate departments to be contacted to have issues addressed. Staff noted they will work on this and have a mailout prepared shortly.

#### 2. Wharf Project Update, FA230316

Council brought forward several concerns regarding the quote, specifically regarding the ability of the Fire Department to respond to fires on the Wharf with the use of the trailer and hoses. It was recommended that staff review the opportunities and costs for a hard line fire suppression line to be run along the Wharf.

Councillor Harland thanked Town staff for the information on the By-Law processes and for answering the questions of frustrated residents.

Councillor Gumushel thanked staff for reviewing the security system footage concerning the missing person who recently recovered. It is a sad time for the community, the third person in the last few years to be lost. Hoping for further discussions at budget time to install more security cameras around Town to help with search processes.

Councillor Weare provided an update on the post-smolt facility from Cooke's Aquaculture. The project is moving forward in the spring and the Province is passing the EIA assessment with construction to start shortly. Councillor Weare will provide documents to Council for review and further updates as they occur.
