

## **BY-LAW NO. 25-01**

# **A BY-LAW TO REGULATE VEHICULAR TRAFFIC IN THE TOWN OF SAINT ANDREWS**

The Council of the Town of Saint Andrews, under the authority of the *Motor Vehicle Act Ch. 17*, the *Provincial Offences Procedure Act Ch. P-22.1*, the *Highway Act Ch. H-5*, the *Local Governance Act*, Bill 44, Article 10, enacts a By-Law as follows:

### **1. DEFINITIONS**

- 1.1. The words defined in the *Motor Vehicle Act* of the Province of New Brunswick RT.S.N.B. 1973 and amendments thereto, when used in this By-Law shall have the same meaning as in the said *Act*.
- 1.2. **“BY-LAW ENFORCEMENT OFFICER”** means a person designated by Council to enforce the By-Laws of the Town of Saint Andrews.
- 1.3. **“BUS STOP”** means a street or portion of a street set aside for the exclusive parking of buses for the purpose of allowing passengers to enter or align there-from.
- 1.4. **“COUNCIL”** means the Town Council of the Town of Saint Andrews.
- 1.5. **“CURB”** means the lateral limit of the portion of the street used or intended to be used for vehicles, whether or not marked by curbstones.
- 1.6. **“LOADING ZONE”** means a street or portion of a street set aside for the exclusive short-term parking of commercial vehicles for the purpose of loading and unloading merchandise.
- 1.7. **“OFF-ROAD VEHICLE”** means any motor vehicle designed or adapted for off-road use and, without limiting the generality of the foregoing, includes all-terrain vehicles, dirt bikes, dune buggies, side by sides, motorized snow vehicles or amphibious vehicles, but does not include any vehicle which is designed for use and is being used in agriculture, forestry, mining, or construction, any vehicle under the *Motor Vehicle Act* or any vehicle exempt for this application of this By-Law.
- 1.8. **“PEACE OFFICER”** means the Royal Canadian Mounted Police assigned to the Town of Saint Andrews under an agreement between Public Safety Canada and the Town, or any other Police agency operating under an agreement with the Town for the policing of the Town of Saint Andrews.
- 1.9. **“STREET”** means the entire width between the boundary lines of every public street, road, highway, lane, alley, square, Town-owned lot of land, park, all parking lots, school entrances or exits, or place where any part thereof is used by the general public for the passage of vehicles and includes bridges thereon.
- 1.10. **“TOWN”** means the Town of Saint Andrews, Ward of Bayside, and Ward of Chamcook.
- 1.11. **“TRAFFIC CONTROL DEVICE”** means a device, signal, or sign for the regulation, warning, or guidance of traffic.

## **2. SCHEDULE AMENDMENTS**

- 2.1. Subject to obtaining the sanctions of the Lieutenant-Governor in Council, when the By-Law relates to a portion of a Provincial Highway, the Council may from time to time amend Schedule “A” to “J” inclusive of this By-Law.

## **3. AUTHORITY OF PEACE OFFICERS AND BY-LAW ENFORCEMENT OFFICERS**

- 3.1. It shall be the duty of the By-Law Enforcement Officer and Peace Officers to enforce all traffic By-Laws of the Town and the *Motor Vehicle Act* of the Province of New Brunswick.
- 3.2. Peace Officers are authorized in case of an accident, emergency, or parade, to re-route traffic and to prohibit the movement of traffic on any street in Town.
- 3.3. It shall be lawful for a Peace Officer or By-Law Enforcement Officer to move or cause to be moved any vehicle found stopped or parked in violation of the provisions of this By-Law, on any street in Town.
- 3.4. A vehicle so moved under this By-Law shall be stored in such place as the Peace Officer may decide, and the registered owner of such vehicle at the time shall be liable for costs and charges for the storage and moving thereof.
- 3.5. There will be no liability attached to the Town or a member of the police force for any damages to a vehicle moved or taken into custody under this section.

## **4. PROVINCIAL HIGHWAY**

- 4.1. Subject to obtaining the sanctions of the Lieutenant-Governor in Council, when the By-Law relates to a portion of a Provincial Highway, the Council may from time to time designate by amendment of this By-Law:
  - 4.1.1. The time and mode of parking on any street.
  - 4.1.2. The direction of traffic on one-way streets.
  - 4.1.3. The loading and unloading zones.
  - 4.1.4. The prohibition of parking on any street, or portion thereof; and
  - 4.1.5. The placing of traffic control devices as deemed necessary to regulate, warn, or guide traffic.

## **5. SPEED LIMITS**

- 5.1. On any municipal street, no person shall drive, starting from the intersection of Mowat Drive, Bayview Drive, and Reed Avenue, at a speed in excess of forty (40) kilometers per hour.
- 5.2. No person shall drive a vehicle in excess of twenty (10) kilometers per hour on the Saint Andrews Market Wharf, W.C. O'Neill Arena

Complex Parking Lot, Harry Mallory Sports Field, and Community Youth Activity Centre Parking Lot.

- 5.3. All speeding fines and offences are subject to the *Provincial Offences Procedure Act*, and the regulations of the *Highway Act* and *Motor Vehicle Act* of the Province of New Brunswick.

## **6. NON-VEHICULAR TRAFFIC**

- 6.1. Non-Vehicular Traffic is subject to By-Law No. 22-03, A By-Law to Regulate Non-Vehicular Transportation within the Town of Saint Andrews or version thereof.
- 6.2. No driver of a vehicle, on any street, will drive to splash water, mud, or snow on any pedestrians.
- 6.3. With respect to movement, all Non-Vehicular Traffic is regulated under the *Motor Vehicle Act*, Chapter M-17, Statutes of New Brunswick, which regulates the movement of bicycles.
- 6.4. No person shall ride upon, operate, or use a sled or toboggan on a sidewalk or street other than being pulled by a person.

## **7. ANGLED AND PARALLEL PARKING**

- 7.1. Where angled parking is permitted, a vehicle shall be parked at a forty-five-degree (45°) angle to the curb or boundary of such street, so that the front or back of the vehicle is nearest to the curb or boundary of the street.
- 7.2. When angled or parallel parking spaces are indicated by suitable markings, no vehicle shall be stopped except within the marked limits of a parking space.
- 7.3. This section is subject to subsection 194(4) of the *Motor Vehicle Act*.

## **8. BUS STOPS AND BUS PARKING**

- 8.1. The streets designated in Schedule "A" are set aside for the exclusive parking of buses for the purpose of allowing passengers to enter or disembark there-from, and no person shall park a vehicle between the limits of said streets. Buses may stop momentarily for the purposes of embarkation and disembarkation.
- 8.2. Buses are not allowed to stop on crosswalks, in front of fire hydrants, or blocking accessible parking spots.

## **9. SCHOOL ZONES**

- 9.1. School Zones shall be in accordance with Schedule "B".
- 9.2. No person shall drive a vehicle in a school zone in excess of thirty (30) kilometers per hour during the hours of 07:00 hrs. and 16:00 hrs. on the days during which a school in the vicinity of a school zone is in session.

## **10. NO PARKING ANYTIME**

- 10.1. No person shall park a vehicle on the side and between the limits of the streets designated in Schedule “C” or in areas identified by yellow-painted curbs indicating No Parking areas.

## **11. OVERNIGHT PARKING**

- 11.1. During the period from the 15<sup>th</sup> day of November in any year to the 31<sup>st</sup> day of March in the following year, no person shall park any vehicle on any street or any Town owned parking lots between the hours of 02:00 hrs. and 07:00 hrs.
- 11.2. Unless otherwise directed by a Town Official, parking on the east side of William Street from Water Street to the shore is exempt from Section 11.1 of this By-Law.

## **12. ACCESSIBLE PARKING**

- 12.1. Accessible Parking shall be in accordance with Schedule “D”.
- 12.2. No person shall stop, stand, or park a motor vehicle in a location reserved for Accessible Parking unless there is displayed on or in the vehicle, a disability identification plate, permit, or placard issued by a Registrar of Motor Vehicles.

## **13. LIMITED PARKING**

- 13.1. Limited parking shall be in accordance with Schedule “E”.
- 13.2. No person shall park beyond 30-minutes in identified parking spaces as per Schedule “E”.
- 13.3. No person shall park in the identified emergency parking space, except for By-Law Enforcement Officer, Peace Officer, Fire Department, or Ambulance.

## **14. ONE-WAY STREET**

- 14.1. Streets set out in Schedule “F” of this By-Law are designed as one-way streets and the driver of a vehicle driving on any of the said streets shall only proceed in the direction specified for the street by the said By-Law.

## **15. PEDESTRIAN CROSSWALKS**

- 15.1. Pedestrian crosswalks shall be in accordance with Schedule “G”.

## **16. TRAFFIC SIGNALS**

- 16.1. Traffic Signals shall be in accordance with Schedule “H”.
- 16.2. No person shall erect a sign in such a manner as to obstruct pedestrian or vehicular traffic or to create a hazard to such traffic or obstruct storm drainage.

## **17. STOP SIGNS AND YIELD SIGNS**

- 17.1. Stop signs and Yield signs shall be in accordance with Schedule "I".
- 17.2. As per the *Motor Vehicle Act* Section 193(1) (g) no person shall stop, stand, or park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the law, within ten (10) metres upon the approach to any flashing beacon, stop sign, or traffic control signal located at the side of the roadway.

## **18. RESTRICTIONS ON ON-STREET USE**

- 18.1. No person shall overhaul or repair a motor vehicle or trailer on any public street or square unless in the case of an emergency.
- 18.2. All commercial trailers and any unattended trailers located on Town Street, parking lots, or parks for greater than 24 hours (i.e. trailers not attached to a vehicle parked on Town Streets, parking lots, or parks) will be marked with safety cones or safety pylons.
- 18.3. No person shall stop or park a motor vehicle on any sidewalk or portion of a sidewalk without the consent of the Chief Administrative Officer or designate.
- 18.4. No person shall stop, stand, or park a motor vehicle whether attending or otherwise, except when necessary to avoid conflict with other traffic in compliance with this By-Law or the direction of a By-Law Enforcement Officer, Peace Officer, or traffic control device in any of the following places:
  - 18.4.1. In front of any public or private driveway in part or in whole.
  - 18.4.2. On or within three (3) metres in any direction of a crosswalk, unless so indicated as a place to park.
  - 18.4.3. Facing the opposite direction of traffic on either side of the road.
  - 18.4.4. In a location marked as a fire lane or fire hydrant access point.
- 18.5. No person shall deposit, or cause to be deposited, by shovelling, scooping, or ploughing, any snow or foreign material, upon any street, sidewalk, crosswalk, or near any fire hydrant.
- 18.6. No person shall pile or otherwise place snow upon any street, sidewalk, crosswalk, or near any fire hydrant, to the extent that it is likely to become a nuisance or endanger public safety. Any person who does not remove the snow pile within 24 hours of being notified, either verbally or in writing, shall, in addition to the penalties referred to in this By-Law, shall be liable to the Town for all costs incurred by the Town to rectify the situation.

## **19. VEHICLE IDLING**

- 19.1. No person shall cause or permit a vehicle to idle for more than ten (10) consecutive minutes, on Town streets, in accordance with Town of Saint Andrews policies for reducing Greenhouse Gas Emissions.

19.2. Section 19.1 shall not apply to the following:

19.2.1. Police, fire, or ambulance vehicles, while engaged in operational activities, including training.

19.2.2. Vehicles assisting in an emergency activity.

19.2.3. Mobile workshops while using the equipment that must be operated in association with the vehicle.

19.2.4. Vehicles where idling is required to repair the vehicle or to prepare it for service.

19.2.5. Armoured vehicles, where a person remains inside the vehicle while guarding the contents of the vehicle, or while the vehicle is being loaded or unloaded.

19.2.6. Vehicles required to remain motionless due to an emergency, traffic, weather conditions or mechanical difficulty over which the person driving the vehicle has no control.

19.2.7. Transit and passenger vehicles, while passengers are embarking or disembarking in transit or at terminals.

19.2.8. Vehicles transporting a person where a medical doctor certifies in writing that for medical reasons a person in a vehicle requires that temperature or humidity be maintained within a certain range.

19.2.9. Vehicles engaged in work undertaken for or on behalf of the Town of Saint Andrews or Province of New Brunswick.

19.2.10. Vehicles, including hybrid vehicles, that eliminate the emission of greenhouse gases and criteria air contaminants during the idling phase of operation.

19.2.11. Delivery vehicles that are loading and unloading to deliver supplies to local establishments.

## **20. PARADES AND PROCESSIONS**

20.1. No person shall operate, hold, or conduct a parade, procession, assemblage, or street closure, except a funeral procession, on any highway or street in the Town without first obtaining permission, in writing from the Chief Administrative Officer or designate. The permission shall set out the hour, date, and route or location of the parade, procession, assemblage, or street closure.

20.2. No person shall assemble with others on any highway or street within the Town to obstruct the passage of other vehicles or pedestrians without first obtaining the permission of the Chief Administrative Officer or designate.

## **21. OFF-ROAD VEHICLES**

21.1. No person, including the driver or passenger, shall ride an off-road vehicle on streets or trails within the Ward of Saint Andrews limits.

- 21.2. A person may operate an off-road vehicle on a street within the Town for the purposes of loading or unloading the vehicles from or onto a trailer or truck and into a building or property.
- 21.3. No person shall operate an off-road vehicle within the Town between the hours of 21:00 hrs. and 07:00 hrs. as regulated under the Noise By-Law in the Town of Saint Andrews.
- 21.4. Notwithstanding Section 21.1, the provisions of this By-Law shall not apply to:
  - 21.4.1. Peace Officers, Federal and Provincial Law Enforcement Officers including Fish and Wildlife Officers and Conservation Officers, while engaged in their lawful duties.
  - 21.4.2. Agents for the Town of Saint Andrews while engaged in work on behalf of the Town.
  - 21.4.3. Any off-road vehicles being operated by the Canadian Department of National Defense.
  - 21.4.4. During an emergency, disaster, or search and rescue operation within the Town.
  - 21.4.5. The Chief Administrative Officer or their designate may grant permission for the operation of off-road vehicles within the Town and waive any provisions contained in this By-Law for a designated time or a special event at a location sanctioned by the Town, which includes the Canada Day Parade and the Santa Claus Parade.
- 21.5. Off-road vehicles can be used for snow plowing purposes and can traverse Town streets to move from property to property.

## **22. RIDESHARE PROGRAMS**

- 22.1. For profit rideshare programs in Saint Andrews shall obtain permission from Council to operate within Town of Saint Andrews limits.

## **23. NO OVER NIGHT CAMPING ON TOWN STREETS, PARKING LOTS, OR PARKS**

- 23.1. No overnight camping is allowed on the Town of Saint Andrews streets, parking lots, or parks; this includes tents, campers, and recreation vehicles. Those who are found camping will be issued a 24-hour educational warning and requested to not be camping on Town streets, parking lots, or parks anytime after the warning is issued. Licence plate information will be kept for tracking purposes.
- 23.2. If found camping on Town streets, parking lots or parks after being issued a 24-hour educational warning notice, the person(s) will be subject to Administrative Penalties.

## **24. DESIGNATED PARKING**

- 24.1. The Town of Saint Andrews reserves the right to designate parking spaces in the municipality for use by the Town or other designated organizations. Please see Schedule "J" for more information.

## 25. OFFENCES AND ADMINISTRATIVE PENALTIES

- 25.1. Any person who violates a provision of this By-Law is guilty of an offence.
- 25.2. All contraventions of this By-Law are designated By-Law contraventions that may be dealt with by a Notice of Penalty pursuant to the provisions of the *Local Governance Act* and the *Provincial Offences and Procedure Act*.
- 25.3. All speeding fines and offences are subject to the *Provincial Offences Procedure Act*, and the regulations of the *Highway Act* and *Motor Vehicle Act* of the Province of New Brunswick.
- 25.4. The Administrative Penalty for a contravention of this By-Law shall be as shown on Schedule "K" Administrative Penalty Schedule of Fines.
- 25.5. If three Administrative Penalties have been issued to one vehicle without payment to the Town of Saint Andrews, the vehicle can be towed at the owner's expense.
- 25.6. A person to whom a penalty notice is delivered may pay the Administrative Penalty on or before a charge pertaining to the offence has been laid in Provincial Court as follows:
  - 25.6.1. In-person at the Town of Saint Andrews Office, 212 Water Street, Saint Andrews, New Brunswick, by cash, debit card, credit card, money order, or bank draft, payable to the Town of Saint Andrews.
  - 25.6.2. By mail to: Town of Saint Andrews, 212 Water Street, Saint Andrews, New Brunswick, E5B 1B4 by money order or bank draft payable to the Town of Saint Andrews.
  - 25.6.3. Electronically by credit card at [www.townofsaintandrews.ca](http://www.townofsaintandrews.ca) through the online payment system on the Town's website.
  - 25.6.4. E-Transfer to [payments@townofstandrews.ca](mailto:payments@townofstandrews.ca)
  - 25.6.5. By phone to the Town of Saint Andrews at 506 – 529 – 5120 with a credit card.
- 25.7. A person who pays the Administrative Penalty shall be deemed to have contravened the provision of the By-Law in respect of which payment was made and shall not be charged with an offence in respect of the same incident that gave rise to the Administrative Penalty.
- 25.8. If the Administrative Penalty is not paid in accordance with Section 22.4, the person charged with the offence is liable on summary conviction to a fine up to five hundred dollars (\$500.00).
- 25.9. Administrative Penalties that are not paid to the Town of Saint Andrews after 60 days are subject to the Court of Kings Bench.
